As an influencer, you can boost your earnings through exclusive bonuses and benefits based on your audience and client activity.

## ELIGIBILITY REQUIREMENTS

To qualify for the IB Influencer Program and start earning commissions, you must meet the following criteria:



Be a registered client of 4XC.



Have an active trading account with 4XC.

Have at least 5,000 followers on any social media platform.\*

\*WhatsApp is not considered a social media platform

## SPECIAL IB INFLUENCER COMMISSIONS

- ✓ **Minimum Monthly Net Deposit** > **\$5,000.** If Net deposits fall below this, commissions will not be paid.
- ✓ **Maximum Commission** > **Capped at \$10,000** for monthly Net Deposits exceeding \$100,000.
- ✓ **Commission Rate** > **10%** of the monthly Net Deposit.
- ✓ **Volume Based Commission** > Extra Income **Withdrawable Daily.**

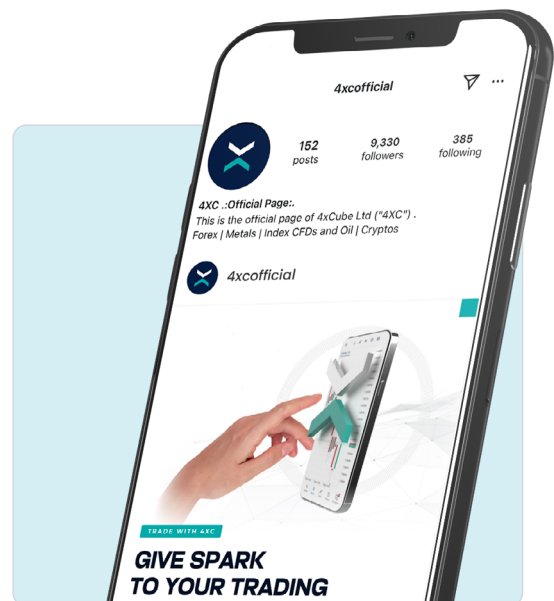
### EXAMPLE CALCULATIONS

<b>1</b>	Net Deposit: <b>\$6,000</b>	Commission: <b>10% of \$6,000=\$600</b>	Total Paid: <b>\$600</b>
<b>2</b>	Net Deposit: <b>\$50,000</b>	Commission: <b>10% of \$50,000=\$5,000</b>	Total Paid: <b>\$5,000</b>
<b>3</b>	Net Deposit: <b>\$120,000</b>	Commission: <b>10% of \$120,000=\$12,000</b>	Total Paid: <b>\$10,000</b> (capped)
<b>4</b>	Net Deposit: <b>\$4,000</b>	Commission: <b>10% of \$4,000=\$400</b>	Total Paid: <b>\$0</b> (below threshold)

## INFLUENCER RESPONSIBILITIES

To keep earning commissions, you must:

- ✓ Promote 4XC by posting at least one video or post per week about our services on YouTube or your social media platforms (Instagram Stories do not count as a post).
- ✓ Ensure your IB links are placed correctly for accurate tracking of commissions.
- ✓ Comply with affiliate marketing laws and regulations.



## PAYMENT TERMS

- ✓ **Payment Timeframe:** Commissions are paid after a 2-month delay (e.g., commissions earned in January are paid in March).
- ✓ **Net Deposits:** To receive a payout, your total Net Deposits must be positive up until the payout month.
- ✓ **Sequential Payments:** If you have consecutive positive months:
  - January commissions paid in March.
  - February commissions paid in April.
- ✓ **Handling Negative Balances:** If one month has a positive balance and the next has a negative balance, deductions will be made from the following payout.



## COMPLIANCE GUIDELINES

As an Influencer in our IB program, you must:

- ✓ **Adhere to 4XC's terms and conditions**, including ethical marketing practices.
- ✓ **Disclose your affiliate relationship** with 4XC to your audience.
- ✓ **Understand that 4XC reserves the right** to modify or terminate this program at any time.
