






STEP 2

DOCUMENT VERIFICATION

Required Documents

To become a verified customer, 4XC requires specific identification documents, which must be submitted, reviewed, and approved.

FOR INDIVIDUAL ACCOUNTS

PROOF OF IDENTITY

High-quality scan or photo of one of the following:

- Passport
- · National ID Card
- · Driver's License

PROOF OF ADDRESS

(document must include name, address, and issue date, not older than 6 months)

- Utility bill (electricity, water, gas)
- Internet, landline phone, or cable TV bill (mobile phone bills are NOT accepted)
- Bank statement, card statement, or tax statement
- Official government-issued document
- · Rental agreement

FOR CORPORATE ACCOUNTS

- Valid ID/Passport for Directors/ Shareholders
- Proof of Residence for Directors/
 Shareholders (issued within the last 6 months)
- Certificate of Incorporation
- Certificate of Registered Office
- Certificate of Directors
- · Certificate of Shareholders
- Memorandum and Articles of Association (not required if a separate document shows Directors and Shareholders)
- Company Utility Bill or Bank
 Statement (issued within the last 6 months)

*Mobile phone bills, insurance documents, and payslips are NOT accepted as valid proofs of address.



Applicants will receive an email confirmation once their account has been verified. If further documents are required, 4XC will contact the client via email.




Two-Factor Authentication (2FA): Clients must enable 2FA authentication via email, an authentication app, or both.












Demo accounts allow for practice, strategy testing, and learning.






