## **“TradingView Coupons” Terms and Conditions:**

### **1. Promotion Overview**

- 1.1 This promotion provides a guaranteed prize for all participants who complete the registration form and request the TradingView coupon.
- 1.2 The organiser reserves the right to end the promotion once all prizes have been claimed. A total of 100 coupons are available.

### **2. Promotion Period**

- 2.1 The promotion is valid from **November 25th, 2024, to January 10th, 2025.**

### **3. Eligibility**

- 3.1 This promotion is open to individuals aged 18 or older.
- 3.2 Only one entry per person is allowed.
- 3.3 Only 4XC clients who have successfully passed the KYC process and have a fully verified account are eligible to participate.

- 4.2 Upon successful submission of the form, 4XC will review the details and, if approved, issue a coupon code for the 3-month TradingView Essential subscription. 4XC will contact participants with their coupon code by email. All participants who complete the form and request the TradingView coupon will receive a TradingView coupon valued at €14.95 per month for 3 months. The coupon will be sent to the email address provided in the registration form, which must match the email address associated with your 4XC account. The delivery will occur within 10 business days of submission.

## 5. Usage of the Coupon

- 5.1 The coupon provides a \$44.85 credit toward any TradingView subscription. While the credit fully covers 3 months of the Essential plan, it can also be applied as a discount toward higher plans (Plus or Premium).
- 5.2 Participants must create a TradingView account via 4XC's dedicated link or directly on the TradingView pricing page to redeem the coupon.
- 5.3 The coupon can be used within 6 months after the start of the Promo Period.
